



Canada

- The S&P/TSX Composite increased 2.22% on the week led by a 6.60% increase in the Materials sector.
- According to Statistics Canada Canadian retail sales rose for the fourth straight month, the longest growth streak since early 2022, signaling the central bank's interest-rate cuts are boosting consumer spending. An advanced estimate suggests receipts for retailers jumped 0.7% in October, the strongest pace since July, following a 0.4% gain in September.

United States

- The S&P/500 Composite increased 1.68% on the week.
- S&P Global's flash US composite PMI, which captures activity in both the services and manufacturing sectors, came in at 55.3 in November, up from 54.1 in October. Economists had expected the index to tick up to 54.3. November's S&P composite PMI signaled the fastest expansion of business activity since April 2022.
