- The S&P/TSX Composite decreased 1.32% on thine week led by a 5.99% decrease in the Information Technology sector.
- According to Statistics Canada Canadian retail sales surged by 2.5% to \$69.6 billion in December, the largest monthly increase since 2022. The increase came as sales at supermarkets and other grocery retailers, except convenience retailers, gained 3.9%, while beer, wine and liquor retailers rose 3.9%t and specialty food stores added 2.4%.
